## NOTICE ABOUT AMENDMENT IN TENTATIVE SEAT MATRIX

The following participating institutions have requested for modification(s) in the tentative seat matrix for AIQ PG 2014.

- I. Central Government Institutions (with OBC reservation)
  - Maulana Azad Medical College, New Delhi vide their email dated 13/02/2014 has requested to withdraw (reduce) one MD-Radiotherapy seat from All India Quota (AIQ) as Delhi University has de-recognized this course.
    - Therefore, one seat of MD Radiotherapy is deleted from the tentative Seat Matrix of All India Quota (AIQ) PG 2014.
  - 2. Vallabbhai Patel Chest Institute (VPCI), vide their letter dated 11/02/2014 has requested to include two seats of DTCD (Diploma in TB & Chest Diseases) as Delhi University has permitted to admit candidates in this course. Therefore, 2 seats of DTCD in VPCI New Delhi are being added in tentative Seat Matrix of All India Quota (AIQ) PG 2014.
- II. Participating Institution Other than Central Government.
  - B.J. Medical College, Ahmadabad (Gujarat) vide letter dated 14/02/2014, has requested to reduce All India Quota in following subject due to transfer/resignation/retirement of PG teachers.
    - (a) MD-General Medicine reduce by 3 (-3).
    - (b) MS- Orthopedics reduce by 3 (-3).
    - (c) Diploma in Obst. & Gynae (DGO) reduce by 1 (-1).

Therefore, the above mentioned seats are being reduced (deleted) from the tentative Seat Matrix of All India Quota (AIQ) PG 2014, as requested.

- 2. Bangalore Medical College & Research Institute, Bangalore, Karnataka, vide their email dated 18/02/2014 has requested to add the following seats in AIQ PG 2014:
