## UPON hearing the counsel the Court made the following O R D E R

- The National Medical Commission has sought a modification of the time schedule for completion of admissions for post graduate medical courses for 2022-2023. The time schedule was laid down in the judgment of this Court in **Ashish Ranjan and Others vs Union of India and Others** [2016) 11 SCC 225.
- The extension has been sought by the National Medical Commission on the ground that as a result of the lock down and later restrictions during Covid-19, counselling for admissions in 2020-2021 and 2021-2022 could not be conducted in accordance with the time schedule and the academic sessions commenced with delay. As a consequence, the declaration of results was delayed.
- 3 The explanation which has been tendered by the National Medical Commission is *bona fide*.
- We accordingly allow the application by extending the time for completing the admission process for post graduate courses for 2022-2023 in terms of the schedule indicated in Annexure 5 to the application which is extracted below:
