Hence, these candidates are **NOT PERMITTED** to participate in the All India UG Counselling 2024 being conducted by Medical Counselling Committee (MCC) and the UG counselling to be conducted by state counselling authorities, in light of the CBI report.

In case any candidate from the list has been allotted in Round-1 of UG Counselling 2024 conducted by MCC, the Provisional Allotment Letter of such candidate will be withheld by MCC till further directions from CBI.
